John R. Hummel Elementary School Title 1 Parent & Family Engagement Policy 2022-2023 Academic School Year

This policy has been jointly developed and agreed upon by the John R. Hummel Elementary School and parents of students served in the school pursuant to Title I.

John R. Hummel Elementary School will convene an annual meeting, at a convenient time for parents to evaluate this policy. This first meeting was held September 29, 2022 during the Virtual Open House at 6:00 p.m. and shared again on October 6 during the SOT meeting. The school's Parent & Family Engagement policy, developed by Erica Etienne, and staff, and parents, will be distributed in an understandable and uniform format and to the extent practicable, in a language parents can understand. The parent & Family Engagement policy will also be made available to the community.

CCSD & Hummel Family survey data was reviewed on 9/29 and 10/6. Data showed that parents wanted support and more parent trainings and classes as well as translators to serve the community. As a result, the FACES is now on campus and open to the school community five days a week. The FACES center has been instrumental in gaining more parent participation through phone calls, and translated documents, and parent conferences.

John R. Hummel Elementary School will involve parents in an organized, ongoing and timely way in the planning, review and improvement of Title I programs, school improvement plan and Parent & Family Engagement policy through parent meetings 9/1, 10/6, 11/3, 12/1, 1/5, 2/2, 3/2, 4/6, & 5/4.

The Educational & Family Engagement Accords were accessed online through the Infinite Campus portal as part of the 2022-2023 student registration packet when any parent re-registers for school. For parents new to the school, the Accords are available through online registration/ campus portal to make clear to parents how they could partner in their child's education. These will be used as needed.

## A. Administration and staff will:

1. Provide assistance to parents, as appropriate, in understanding such topics as the state's academic content and achievement standards, state and local assessments, the requirements of Title I, how to monitor their student's academic progress and how to work with school staff to improve the achievement of the student. Parent-Teacher Conferences will be held as designated by the Clark County School District. Progress reports will be sent home every three weeks and grades will be posted weekly in the Campus Portal. At this time student academic achievement will be discussed, as well as a plan establish a plan for future student academic progress.

2. Provide high-quality curriculum and instruction in a supportive and effective learning environment enabling students to meet the state academic standards. The Nevada Academic Content Standards will be the basis of instruction Reach for Reading, FastBridge, EnVisions, ST Math, Imagine Learning (EL learners) web-based computer programs were purchased to assist students who are having difficulty with reading comprehension and math computation to improve in those areas.

3. Hummel Elementary School will offer parent & Family Engagement activities in the school that will include opportunities for parents to volunteer and be involved in school activities:

- FACES Parent Engagement Center on Campus-daily weekly monthly & trainings and translation for parents;
- Staff development and parent education;

- Parents to provide home support for their children's education, PSTAPT Week:10/10-10/14)
- Parents to participate in school decision-making: AB394 S.O.T. Meetings: 9/1, 10/6, 11/3, 12/1, 1/5, 2/2, 3/2, 4/6, 5/4.
- Effective communication between the school and parents: Parentlinks, Class Dojo, Newsletters/Flyers, Website;
- Family Movie Nights, Career Week, Peace Week, and Field Day, etc. *Throughout the year our parent & Family Engagement activities will be scheduled on various days throughout the week.*

B. Hummel Elementary School will provide materials and training to help parents work with their children to improve the student's achievement, such as literacy training and using technology as appropriate, to foster parental involvement. Provide access to educational resources for parents to use together with their children. A second computer provides students with more opportunities to be exposed to technology, as well as an assessment tool.

C. With regard to professional development, the administration will,

with the assistance of parents, educate teachers, pupil service personnel, principals and other staff in:

D. Hummel Elementary School newsletter; it will be going home periodically, throughout the school year, as well as ParentLink voice messages and email to communicate with parents. Progress reports are generated and parents will be able to access these on Infinite Campus every three weeks.

## E .Coordination with other programs

The administration will:

To the extent feasible and appropriate, coordinate and integrate parent & Family Engagement programs and activities through the FACES department with Read by 3, Reading First, and Pre-K Early Childhood., and conduct other activities such as parent resource centers that encourage and support parents in more fully participating in the education of their children.
